IBCS Association and ISO International Organization for Standardization

Jürgen Faisst informs about the status of the ISO Standard initiative. After the presentation in Brussels everything looks very good. The ISO checked the countries which have the right to vote. There was not a single country saying that converting the IBCS standard into an ISO standard is not a good idea. So we started the ballot with the application. Regrettably, only four countries were sending an expert: PRT (Diego), DEU (Faisst), USA and CHN. ISO requests at least five countries though.

One week later JPN informed that they finally registered an expert. Unfortunately this was too late.

The weak support with experts is due to the fact that the IBCS initiative is assigned to ISO/TC 37 which is about language. The members of ISO/TC 37 are translators, interpreters and linguists rather than business analytics and visualization specialists. Nevertheless, we decided not to change the TC in order not to start from scratch. It still might happen that after accepting the new project, ISO or local standardization bodies decide to change the assignment.

We did some lobbying and succeeded in registering additional experts from Switzerland, Italy, Turkey, Hungary, and Australia. Then we started a new ballot which will end on July 15, 2024. This time we are already assigned an ISO code: ISO/NP 24896 (NP stands for new project).

Questions:

Felix Becker: Is it a disadvantage, that we are in the language group?

Jürgen Faisst: Not really, at the moment it is important to get the project registered. It would be more risky to

change to another group at this stage
